## **Selectboard comments:**

Selectboard Vice-Chair, Rebecca White asked to have a zero-tolerance for discrimination and to have an ethical standard that the Board members would adhere to.

Selectboard Member, Alan Johnson sees the conversation continuing. There are expectations of the public for their elected officials. He sees the Selectboard as overseers of the Town.

Selectboard Member, Dennis Brown likes everyone just the way they are.

## 2. Board Reports, Motions & Ordinances:

- a. Race Relations Committee:
  - Name of Committee.

Selectboard Vice-Chair, Rebecca White made the motion to name the committee: Hartford Committee on Racial Inequality. Selectboard clerk, Sandra Mariotti seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

• Term of Committee.

Selectboard Vice-Chair, Rebecca White made the motion that: The term of this committee shall end upon completion of the charge, anticipated to be no longer than one year from the date of constitution. Selectboard clerk, Sandra Mariotti seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

• Constitution of Committee.

Selectboard Clerk, Sandra Mariotti made the motion that: This advisory committee will be constituted of seven members comprised of two Selectboard members and five Selectboard appointees. Each member will have equal weight in discussion and voting. The Committee will elect its own Chair, Vice-Chair and Clerk. Selectboard member, Simon Dennis seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

Selectboard Committee Members. Selectboard member, Alan Johnson made the motion that: Selectboard Vice-Chair, Rebecca White and Selectboard Member, Simon Dennis, be the Selectboard representatives. Selectboard member, Dennis Brown seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

• Charge of Committee.

Selectboard member, Dennis Brown made the motion that:

To decide upon recommendations to the Selectboard regarding measures that will address and challenge instances of racism, such as racial diversity, sensitivity or implicit bias training program(s) for attendance to the Selectboard and others for the purpose to support people of color and ensure the Town of Hartford is a welcoming and safe place. Selectboard Member, Alan Johnson seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

Selectboard member, Simon Dennis made the motion that: To decide to recommendations to the Selectboard regarding other actions that Hartford can take to respond to incidents of racism, such as, but not limited to the implementation of policy regarding ethical standards for comportment and accountability of elected officials and how the Town will respond in the event that they are not adhered to. Selectboard member, Alan Johnson seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

Selectboard member, Alan Johnson made the motion that: To provide recommendations to the Selectboard about the need for a permanent advisory committee. Recommendations will discuss the name, charge and constitution of the committee. Selectboard clerk, Sandra Mariotti seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

Selectboard Vice-Chair, Rebecca White made the motion that: To communicate about recommendations with the Selectboard at their regular scheduled meetings, and with the general public as appropriate at public forums. Selectboard Clerk, Sandra Mariotti seconded the motion. 7 members voted aye, 0 members voted nay and 0 members abstained.

The membership process will be put together and then advertised for the public openings. The open positions will be advertised for 30 days. Selectboard Clerk, Sandra Mariotti will collect the applications and contact all the applicants. The applicants will be presented to the Selectboard for selection to the committee.
