The Wendal A. Barwood Arena has been receiving heavy use this winter. It was reported by Scott that a record number of people have used the Barwood Arena over the last month. Scott speculated the record number of folks using the WABA could be because of poor winter weather for skiing at the Quechee ski area. Scott reported that the battery charger used for the batteries in the WABA Zamboni has been replaced. The cost of the charger has been paid for by the town's insurance carrier.

Hanover, New Hampshire's Recreation Department borrowed the Town of Hartford's Zamboni, as theirs had broken down. It was borrowed for just one day.
