6:30 PM General Updates

- Abundant Sun Training Report out Feb. 28 meeting
 - Ally: Selectboard has been going through workshops with AS on DEI Training and organizational development and culture. Had third session to process survey data from town employee, elected officials, and volunteers. Looking at next steps and how to share results.
 - Lannie: Should be able to share the results with HCOREI
 - Kim: Eight municipalities are participating in the training and survey. Another meeting is happening on Monday the 20th. Data *will* be shared but it needs interpretation.
 - Ab Sun is willing to present to Hartford department heads.
- Community Safety Review
 - Police and fire chief have provided comments on RFP. The RFP can go out now that the budget has been approved. Money can't be spent until new fiscal year starts in July.
- Ann Raynolds Memoriam

- Discussion about creation of a Hartford student award in Ann's name. Funds would come from community, not town budget.
 - Kim: The school distributes many individual scholarships every year at awards night and might be willing to manage the financial logistics of a scholarship.
 - Pat will talk with Chris Raynolds about whether family is supportive of the creation of a community-based award.
- Joe: Propose resolution voted on by Selectboard honoring work of Ann Raynolds.
 - Pat will draft a resolution and pass to Selectboard member. Will reach out the Tom DeBalsi for words.

7:00 PM Charge

- Selectboard debrief 2/21
 - Some Selectboard members felt weren't informed sufficiently about proposed charge changes
 - Discussion included:
 - Lannie: It was hard to figure out what the changes in the charge were.
 - Sara: Will make clearer what changes were in the future.
 - Russ: In the future, could review the change in one meeting "first reading" and then vote in the next.
 - Mary Gannon: Seemed in Selectboard meeting, there was not clarity with all members about the language being used.
 - Discussion about expanding charge from focus on racial equity to include "social equity" and encompass other areas.
 - John: May be a good topic for a joint School Board, Selectboard, HCOREI meeting.
- School board debrief 3/8
 - Question raised of whether HCOREI should still report to both boards.
 - [Joe, John]: HCOREI is most effective as an internal town/school committee.
 - Sara: Would like to make more space for school board considerations in future HCOREI meetings
 - Michelle: Select and School boards should meet with HCOREI at the same time, e.g., twice vear.
