Significant Activity Report, July 5 – August 1, 2017**

TOWN MANAGER HIGHLIGHTS

- Respectfully submitted for your consideration.
- The State has provided an update on the Gorge Bridge Suicide Prevention project. The Valley News did a great piece on the topic. Bottom-Line: The State is proceeding with planning efforts. No clear indication at this time which option is most favored. The first is scoping and should begin soon.
- The Town's application for Sales Tax Reallocation has been approved for the entire amount requested. More will follow on the next steps.
- We received a letter from the Department of Corrections that they will no longer be able to provide Community Work Crews. We are assessing possible ways ahead and working to fully understand the impact on the Town and other organizations within the Town who use the service.
- The school has asked if the Selectboard is interested in a Joint Retreat on August 23rd. This topic had come up in previous conversations. They are looking for any feedback on potential topics and format.
- The Town continues to work with delinquent taxpayers. Over the past few months we entered into 32 payment agreements. Of those, 11 are paying as agreed, 10 are not paying, 9 have paid of their taxes and 2 are paying intermittently. As you know, we have 22 with the lawyer for delinquent tax sales.
- The Town Staff once again participated in the "Take a Bite Out of Hunger" campaign and successfully donated enough food to fill the 60 backpacks we signed up for. We received additional donations and will work to get those into the right hands for distribution to children in the Town.
- The Town has been actively using a Vinegar/Soap/Salt mixture instead of Glyphosate products to control weeds. It appears to be working well, we'll see what happens over time. I have pictures of effects after 24 hours.
- Listed below are those highlights pulled from each Department Head's report. Further under are the full highlights from each Department.

STAFF HIGHLIGHTS

- The Assessor has been preparing for BCA appeals. There are a total of 12 appeals, over two days. The first session is complete and the second day is on August 10th.
- Finance is working the Year End Close-Out Process and reviewing Year End Purchase Orders and Encumbrances.
- The Fire Department conducted a Lieutenant assessment center on July 11th. Four candidates participated in the process. Candidates were evaluated on their tactics and strategy, conflict resolution, multi-tasking strategy and interpersonal dynamics. A chief's interview will be conducted this week and a recommendation for promotion will follow. Will Laliberty was selected and promoted to Lieutenant.
- IT installed new public safety server. Began moving services from the old server to the new server. Early testing is showing significant performance improvement in address lookup times (geobase), which has been a persistent issue in the past. A number of services still need to be migrated to the new server.
- The Legion State Baseball Tournament held at Maxfield was well received. We look forward to working with the Post 84 in the future. It appears they may be interested in putting in a bid for next season. The working relationship was very positive and the collaboration worked well related to field prep and clean up. We will evaluate the event to provide some input for next season if they receive the bid.
- July 1 Flood Damage – Planning is working with other Town Departments, Two Rivers Ottauquechee Regional Commission, Green Mountain Economic Development Corporation and Upper Valley Strong to respond to impact on town properties, businesses and residents. To date, 27 known Hartford properties impacted. State and FEMA visits concluded sufficient damage to public infrastructure in Windsor County to meet threshold for Federal Disaster Declaration. Unlikely for private property damage. Continuing to work with UV Strong and individual property owners and businesses in assessing damage and options to repair. For a few properties, exploring with the Regional Planning Commission and Vermont Emergency Management possible Hazard Mitigation Buyout Program eligibility.

- Major Vail attended and successfully completed CALEA Accreditation Manager Training. Detective Sergeant Moody attended and successfully completed Evidence Room Manager's Training.
- July 1, 2017 Flooding: The Highway Department continues to work on the numerous list of washouts that occurred on July 1st. The original list of 53 roads on the washout list has expanded to 56, with the 5 large projects list, of which only a handful are considered major washouts. 18/56 projects have been completed to date with a considerable amount of work completed on many of the projects. The major road damages are as follows:
 - o Hathaway Road: Needs 2 culverts and added gravel.
 - o Neil Road: Work completed last week, in need of an added culvert and a replacement. The paving of the 2,000' section will be covered by the Paving bid with hopes of reimbursement from FEMA.
 - o Podunk Road: major culvert issues (2)/washed road and slope erosion. This road may need a precast concrete box culvert; however that would be a planned project for a future budget year.
 - o School Street: Plugged culvert/road/ditch erosion. The culverts at the top will be replaced and the ditch line repaved.
 - o Wildlife Road: This road is in need of 1 culvert and stone line ditch. This will be completed in August.
 - o Dothan Road: The shoulder repair work has been completed. The replacement culvert section has been ordered and will be installed as soon as it has arrived. Additional barricades and signage have been installed.
 - o By the end of August the list of roads to repair is anticipated to be down to 12 remaining.
- Everett Hammond will serve as the acting Public Works Director while Rich Menge is away on medical leave.

DEPARTMENT HIGHLIGHTS

Assessor:

- Set the tax rates, assisted finance in reconciling the tax billing.
- Processed Homesteads and state aid payments.
- Received and reviewing new GIS mapping file.

Fire:

- The department's Annual Compliance Report was submitted to the Center for Public Safety Excellence for approval as required for accreditation.
- Staff attended the "Boots to Boats" event at Kilowatt Park on Sunday. Hartford's swift water rescue equipment was placed on display for the public.
- Staff will be conducting high angle rescue training on July 19th on the ledges behind UVAC. The training is being conducted with both Hanover and Lebanon Fire Department's.
- Attended the VT Career Fire Chief's meeting in Berlin, VT. The group had an opportunity to sit down with Public Safety Commissioner Anderson and discuss his vision and any concerns or recommendations with the fire service in Vermont.
- The department is hosting an Intern from Vermont Technical College Fire Science Program. Chelsey Keyes has been put on staff as a call firefighter and will be working with the rotating shifts over the summer and into the fall.
- The department is hosting ride a long students from the Thetford Advanced Emergency Medical Technician program. Student are riding with ambulance crews to practice assessments and skills.
- The Vermont Department of Health conducted an inspection of both Hartford ambulances. Both passed and received licensing for the next two years.
- Crews attended the Fire Works display at Kilowatt Field on July 4th. The Ladder truck was requested to display the flag during the event.

- Department hose testing has been completed for all apparatus.
- The department provided some equipment to a few residents to assist in the recovery/clean-up after the July 1st storm event.
- Conducted a safety inspection of Gordon property on Old River Rd.
- Conducted a dilapidated building safety inspection at 1526 Old River Rd.
- We were informed by Emergency One in Ocala, FL that the new fire engine ordered in the fall has entered the assembly line at the factory. No delivery date has been provided.
- A new crew cab Utility truck with service body has been ordered by the department. This will replace the 2007 truck that is currently in service. On delivery of the new vehicle, the 2007 truck will be transferred to DPW.
- Firefighter Taylor Wilkins attended a 4 day Rope Operations course and became certified.
- Chief Cooney attended a week long training at Fire Rescue International in Charlotte, NC.
- All ladders and Aerials were tested and certified.
- A public CPR course was held and 8 more people became certified in CPR.
- We have been selected to host a Firefighter 1 & 2 course from the Vermont Fire Academy.
- An initial planning meeting was held in regards to a confined space drill with Hanover and Lebanon.
- An initial planning meeting was held in regards to a swiftwater drill with Lebanon, Hanover, Hartland, Cornish, Meriden and Plainfield. The plan is to have the drill at Summers Falls. Summers Falls is a target hazard that requires multiple agencies during an event.
- Staff attended a CROH meeting ramping up for Resilience Week.
- Staff attended a meeting about an MCI drill at the VA scheduled for August 23rd.

- Progress is being made in regards to the dilapidated building on 1526 Old River Road.
- An engineer is looking at the Stetson Road Bridge about our accessibility.

Parks and Recreation:

- The summer concert continues at Lyman Point Park & The Quechee Green Park with recent performances by John Lackard Blues Band, The Road Trash Band and Jesse Terry. Concerts have been well attended by 100+ people.
- Week's 3 & 4 of Camp Ventures have gone well! We are now mid-way through our summer camp program. Camp Directors will be conducting mid-summer evaluations on camp employees.
- The Teen Adventure Getaway program partnered up with the Quechee Club Rec Department for a Paintball trip on 7/6 we had 5 kids signed up for this trip. We had another teen trip to Jay Peak Pump House on 7/13 and had 9 kids attend this trip.
- Intern, Adam Middleton Developed and implemented original programming for Camp Ventures. This first week included a tick safety talk, a couple rounds of "Tick" Tac Toe, and a scavenger hunt in the forest. Adam also teamed up with the Quechee Club to supervise 13 teens (from Hartford and Quechee) on an adventure trip to OSG Paintball in Barnstead, NH.
- Splash night scheduled at the Sherman Manning Pool on Friday, July 14th from 6:00pm-8:00pm.
- We now have 21 girls signed up for Summer Soccer for Girls.
- Youth Field Hockey Camp occurred the week of 7/10-7/14 at the Hartford High School with 12 participants.
- The 2nd session of swimming lessons have wrapped up on 7/14. Session 3 begins on 7/17.

- Our department is participating in the 2nd Annual Boots to Boats River Splash Event that will take place on Sunday, July 16th.
- The First Tee Golf Program, 2nd Summer Session started on 7/7 with 5 participants.
- Green Mountain Rock Climbing Clinics started on 7/11 with 5 participants.
- The Family Entertainment series kicked off on July 7th with Magic by George. The event was held at the HHS Auditorium (Rain Location) and was attended by 200+ people (including our camp). Thursday, July 13th Bryson Lang performed at the HHS Auditorium with around 150+ in attendance. This events are open for all to attend and free of charge.
- Movie in the Park was held on Friday, 7/14 "Sing" at the Quechee Green Park - This event is sponsored by Members Advantage Community Credit Union and is a free event.
- 4th of July went well. We had a very large crowd with the parking areas filling up quickly. We did have some delays in departing traffic but all went well. The Department will be meeting with the Police Department to evaluate and update any plans for next year's event. The Department is more than appreciate of the support from the Police and Fire Departments for assistance with the festival.
- The Department has been finishing up aeration of sports fields and will be completing application of fertilizer.
- The July storm caused a two small wash outs at Watson Park. The area near the canoe launch may require a permit related to any repairs. We are working with the Planning and Zoning Office to help determine if we need to apply for a permit. The Department also repaired wash outs at the Kilowatt boat landing and at Kilowatt North. The washouts only required repaving of the road and ramp areas. Near the bank areas we reapplied soil materials and reseeded.
- Department continues with mowing of facilities and field prep.
- Projects will be put on hold due to staff shortage with the parks crew. We will focus on mowing and as much detail work as can be managed.
- Park permits have doubled in count as of July 1st. Last year 31 park permits were issued for use of park space. This year we have issued 64 permits to date.
- The auto fill valve at the Outdoor Pool was replaced. We are still experiencing water loss. South Shore is scheduled to be on site to assess conducting a pressure test of

the interior section of the gutter. It is likely the inner chamber is where the leak is located.

- The Department received the final review of the Aquatic Nuisance Grant for Dewey's and will be signing off on the award notice. The grant is for the milfoil extraction program at Dewey's Pond.
- Our intern, Adam Middleton has researched and compiled preliminary naming rights guidelines for park amenities. This policy could provide the Town and Hartford Parks and Recreation with a systematic and consistent approach to naming of assets (benches, pavilions, fields, courts, etc.). This practice should also help offset some of the costs associated with maintaining the parks.
- The Department researched and reached out to manufacturers of replacement tent covers for Sherman Manning Pool.
- The Department met with the organizer of a petition in West Hartford for a new swing set in Clifford Park. The petition was presented to the town in 2015 and prices were received but the project was not completed by the Department. The Department has solicited updated pricing for a one bay, two swing set and hope to have results soon so a solution to the request can be finalized and taken care of.
- The Hurricane Hill Trail Run on Saturday July 22nd had 150 runners complete the race. The race is a collaboration between the Friends of Hartford Track and Parks & Recreation. UVAC also provides space for our day of registration and awards. They allow usage of the facility and provide free passes to runners who compete in the event.
- Activity continues at Maxfield on Thursday and Saturday with Nighthawks.
- 350Vt was issued a permit for a small pop up tent in Lyman Point Park for Thursday, Friday and Saturday July, 27t, 28th and 29th. 9am to 5pm sharing information and doing a questionnaire related to 350Vt.
- Department had a successful trip to the Boston Red Sox with 45 participants in attendance.
- Ventures Summer Camp is near the tail end of summer. Week 5 included a trip to Fisher Cats and Echo Aquarium. Ventures Camp Week 6 had a Friday fun day at Maxfield that included a Color Run.
- The Teen Adventure Getaway program included trips to the Sky Zone and Epic Escape. Both trips were partnerships with the Quechee Club Rec Department.

- Splash night took place on Friday, July 28th from 6:00pm-8:00pm. Weather has caused low attendance.
- Our Department participated in the 2nd Annual Boots to Boats River Splash Event that will take place on Sunday, July 16th.
- The Adult Softball League finishes the season with a tournament the weekend of August 5th.
- Adam Middleton, Parks & Recreation Summer Intern is working with the Upper Valley Dog Park on a user survey.
- We replaced the vacuum pump at the Sherman Manning Pool. The 20 year old pump was replaced with a similar system. We were able to salvage the old pump cart.
- During the week of July 24th the DOC Crew Leader was out with an illness causing the Department to pick up several of the parks for mowing. The DOC was unable to provide a replacement supervisor for the week.
- We are still experiencing water loss at the pool. We have ordered additional stabilizer to see if we can control chlorine usage. We are awaiting a schedule from South Shore to conduct a pressure test. In the meantime we may try to send an underwater camera into the inner chamber of the gutter to see if we can identify areas of leakage.
- We solicited pricing for a two bay swing at Clifford park and received prices. Will evaluate the swing results and plan to purchase the swing set for installation. The Department met with the organizer of the petition in West Hartford for a new swing set in Clifford Park. The petition was presented to the town in 2015. The Department hopes to purchase and install the swing before the end of the park use season.
- Velco is to begin vegetation clearing on the power lines between North and South Kilowatt this week. They are also replacing the treated poles with imbedded steel poles due to proximity to the town well near kilowatt north. They have a planned shutdown of service sometime in September. We will be working with them to identify if the shutdown will impact service at the arena. We begin chilling the arena floor the 3rd week of September.
- Advertising for the Superintendent of Parks & Facilities along with the Laborer Positions have been posted. Application deadline is August 11th.

Planning and Development:

- Quechee Pocket Park – Construction continuing. Making modifications to accommodate unanticipated site conditions such as buried foundation walls and ledge. RediRock walls and concrete work next on schedule.
- Lower Sykes Mt Ave Sidewalk Improvements – Received 6 responses for Request for Construction Management Services on July 20th, now under review. Received 4 bids for project construction on July 25th, ranging from \$544,900 to \$724,920. Lowest bid within the project budget.
- Currier Street Extension TIF Project – Construction of first phase continuing.
- TIF Bond –Bond Bank sale completed on July 13th. Will know final loan repayment schedules after August 2nd bond closing.
- Community Resilience Week – It kicks-off on August 18th with a Hartford community resilience assessment and dinner, continuing throughout the week with panel discussions, hands-on workshops and movies, and ending on August 25th with a dinner at the Bugbee celebrating the Hartford community's resilience.
- Planning Commission and Zoning Board of Adjustment Application – Completing review of applications for a Chevy dealership on Sykes Mountain Avenue, conversion of property across from the Wilder center into a school, office and parking lot; and a lot line adjustment on Passumpsic Ave.
- WRJ National Register Historic District Update – Comments on fist draft submitted to consultant, and revisions completed and on Town website. Presentation and discussion of draft at July 19th community meeting.
- West Hartford Bike Ped Feasibility Study – Final report submitted and Grant closed out.
- Route 5 South Sidewalk Design – Agreed on Town sidewalk alignment and circulation relating to the Dunkin Donuts property.

Police:

- July 2nd – Patrol officers were dispatched to a car versus motorcycle vehicle crash at the intersection of Maple Street and Hartford Avenue. A passenger of the motorcycle was transported to DHMC with minor arm and leg injuries. No other

operators or passengers were injured. The operator of the car was issued a traffic ticket for failing to yield while turning left.

- July 2nd – Patrol officers were dispatched to the 200 block of Norwich Avenue for a reported suicidal male. Officers transported the male to DHMC for evaluation.
- July 2nd – Patrol officers were dispatched to a family fight at a Dawn Drive residence. A male resident was subsequently arrested for 2nd degree aggravated domestic assault, resisting arrest, and unlawful mischief. He was lodged with bail conditions pending a court appearance.

Incident is under investigation.
- July 4th – Patrol officers provided traffic and security control for the annual Hartford Fireworks Festival.
- July 4th – Patrol officers were dispatched to a motor vehicle crash at McDonald’s drive-thru where one vehicle was rear-ended while. The alleged at-fault operator fled the scene. Incident is under investigation.
- July 4th – Patrol officers investigated a report of a male individual claiming to having been “pepper-sprayed” by another individual during a dispute while at the fireworks festival. The male individual was subsequently charged with disorderly conduct and released.
- July 5th – Patrol officers charged a male Hartford resident with operating after license suspension resulting from a traffic stop on South Main Street at Nutt Lane.

- July 17th – Patrol officers assisted Hartford Fire Department Units with traffic management after lightning caused a small fire and knocked powerlines into the roadway near the 200 block of Quechee West Hartford Road.
- July 21st – Patrol officers executed Search & Seizure Warrant(s) at a room in the Quality Inn, Quechee where they located a male fugitive from justice and quantities of illicit drugs, including heroin. The man and his female companion were taken into custody and held at Southern State Correctional Facility on bond.
- July 21st – Patrol officers charged a Hartford Village Teen with the theft of prescription medication taken from the home of a family member.
- July 22nd – Patrol officers responded to a private residence along the 200 block of Christian Street for reports of an intoxicated man. Police found the man had fallen down a flight of stairs and struck his head. Hartford Ambulance was summoned and the man transported to Dartmouth-Hitchcock Medical Center for treatment.
- July 23rd – Patrol officers responded to a room at the Super 8 Hotel for an intoxicated, disorderly guest in crisis. The situation was mediated and Hartford

Ambulance summoned to transport the guest to Dartmouth-Hitchcock Medical Center for treatment.

- July 25th – Patrol officers responded to a collision involving two motor vehicles at the Quechee Gorge Bridge, with the investigation delaying traffic. The at fault driver was cited and released.
- July 27th – Patrol officers responded to a private residence in the 1500 block of Maple Street for a welfare check of man in crisis. Police found the man unconscious. Hartford Ambulance was summoned and the man transported to Dartmouth-Hitchcock Medical Center for treatment.
- July 27th – Patrol officers were dispatched to a home along the 3600 block of Woodstock Road for the theft of several rabbits apparently taken from an outdoor pen. The investigation continues.
- July 28th – Patrol officers have charged a 29 year old Hartford man with numerous traffic violations, including driving under the influence after he drove his car the wrong way onto Interstate 89 South at Exit 1 and failed to stop for police. The man led police on an extended, high speed pursuit into Plainfield, New Hampshire before bottoming-out his vehicle in a field. He was taken into custody after a brief foot pursuit.
- July 29th – Patrol officers are investigating the burglary and theft of cash from a business along the 2200 block of Hartland Road. The investigation continues.
- July 29th – Patrol officers are investigating the theft of a laptop computer taken from a home along the unit block of Hartford Avenue. The investigation continues.

Public Works:

- Solid waste has made a recommendation for a roof replacement for the education building.
- The White River wastewater staff has found a pump that will work in the sump at the headworks building designed to avoid overflows at the plant head works. The new pump is expected to be here in app 1 week.
- The water and Wastewater Departments have been working on the list of safety correction items identified by VLCT.

- The Wastewater Dept. will be pursuing a permanent easement for better access into the Birchwood sewage leach field.
- The Water Dept. completed samples, meter reading and plant maintenance.
- The Water Dept. utilized the GPS unit as practice by assisting the Highway Dept. in identifying the eroded sections of School Street.
- The Wastewater Dept. assisted the Highway Dept. as needed in the jetting of drain lines and culverts.
- Bids were received on the light tower that was put out for bid a couple of weeks ago. This light tower will be used for night time water and wastewater breaks, fire or police issues and any other Town related functions.
- Mold Removal at the Education building at the Recycling Center: Servpro failed the first test and has completed more work since. The testing company moved in for a second test and said that they were not ready. Public Works will be looking for a resolution for a final performance with positive testing from Servpro the week of 7/29/17.
- The White River wastewater crew temporarily patched up the Education Center roof last Thursday (7/27).
- The Water Dept. hosted a leak detection seminar at the Hartford Fire Station on Thursday (7/28). This was attended by 15 people.
- Steve Brock of the wastewater Dept began cross training with the Water Dept.
- The Water Dept. continues to utilize the GPS unit in locating water mains, gate valves and shut offs.
