1. To elect School Officers for the ensuing year. (By Australian Ballot).
2. Shall the members of the Board of School Directors be compensated \$75 per meeting for the school year commencing July 1, 2021, and the Chair of the Board of School Directors be compensated \$300 for the school year commencing July 1, 2021, and the Clerk be compensated \$150 for the school year commencing July 1, 2021? (By Australian Ballot)
3. Shall the voters of the School District approve the School Board to expend \$40,966,683, which is the amount the School Board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$17,294.88 per equalized pupil. This projected spending per equalized pupil is 2.50% lower than spending for the current year. (By Australian Ballot).
