Approval is hereby given for the granting of a permit under the provisions of VSA Title 23, Sec. 1392 and Sec. 1400a, and any amendments thereto, covering the operations of motor vehicles over local highways and bridges with gross loads as follows:

The above vehicle weights are permitted on primary streets (see attached list.) Unless otherwise noted on this permit, secondary streets are limited to 69,000 lbs. During winter thaws, rainy periods, or when frost is coming out, the Select Board may post roads or suspend permits on otherwise approved weight limits. No load in excess of the posting is permitted and blanket permits are suspended. The Town of Hartford has the right to revoke this permit at any time.

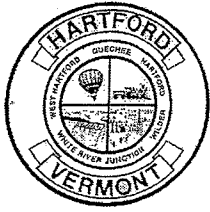

This approval shall be effective for no more than a one year period *ending March 31, 20*____. If a fleet permit, this approval covers all vehicles bearing the company name. If the permit is to cover unmarked company trucks, please attach a list to this form giving the year, make, VIN number, maximum weight and registration number.

The holder of a permit shall be liable for any damage to highways or bridges per VSA Title 23, Sec. 1400a (c) and is required to furnish the municipality a valid Certificate of Insurance in the following amounts: a minimum of \$100,000/\$300,000 Personal Injury Liability Coverage and \$100,000 Property Damage Coverage.

OVERWEIGHT PERMITS INSTRUCTIONS FOR APPLICANT

An annual Uniform Municipal Excess Weight Permit must be obtained from the Town to haul up to 90,000 lbs. on primary streets or up to 69,000 lbs. on secondary streets. Vehicles over 69,000 lbs. that intend to use the Town's secondary streets must obtain a Project Permit that specifies the route of requested travel (see also next paragraph.)

All vehicles in excess of 90,000 lbs. are required to apply for a Project Permit. The Project Permit will be issued for a period of 14 days and is renewable for additional 7 day increments.

UNIFORM MUNICIPAL EXCESS WEIGHT PERMIT

1. Permit is valid for up to one year, expiring on March 31. The Town of Hartford has the right to revoke this permit.
2. Please include an administrative fee of \$5.00 for each single vehicle application or \$10.00 for a fleet permit.
3. You must include a valid certificate of insurance, with the Town of Hartford listed as certificate holder, in the amount of a minimum of \$100,000/\$300,000 Personal Injury Liability Coverage and \$100,000 Property Damage Coverage.
4. Single vehicle permits must be carried in the permitted truck. Fleet permits are not required to be carried in the trucks.
5. Please use the following codes:

6. Truck weight limits and vehicle configuration shall comply with Vermont Title 23- section 1392. Weight limits shall not exceed the following weights per axle group:

<u>Number of axles</u>	<u>Maximum weight</u>
2 axle truck	40,000 lbs.
3 axle truck	60,000 lbs.
4 axle truck	70,000 lbs.
5 axle truck	80,000 lbs.
6 axle truck	90,000 lbs.
2 axle dump & trailer	70,000 lbs.
3 axle dump & trailer	80,000 lbs.

Trucks that receive permits will be allowed to haul up to 90,000 lbs. on primary streets and 69,000 lbs. on secondary streets providing the axle limits are met.

PROJECT PERMIT.

1. Companies that request a permit in excess of the above allowable weights, will have to obtain a project permit and have the route of travel approved by the Town of Hartford. Permits for weights in excess of those listed above shall be good for no more than 14 days. At the Town's discretion, a project permit may be renewed in additional 7 day increments. The Town of Hartford has the right to revoke this permit.
2. You must include a valid certificate of insurance in the amount of a minimum of \$100,000/\$300,000 Personal Injury Liability Coverage and \$100,000 Property Damage Coverage.
3. Project permit fees; \$5 per vehicle and \$10 per fleet for each application and each renewal period.
